"The proposal remains to be unacceptable in principle and there are several matters which should also be addressed as part of any future planning application and which relate to impact on ecology as a result of the site clearance and demolition of part of The Norton, visual impact of the retaining wall, visual impact of the dormer windows in the front roofs of the proposed dwellings, and visual impact of the proposed parking layout. There are concerns that the site may not be able to accommodate any additional dwellings, or the number of dwellings as proposed and mitigate for the ecology that has been lost as a result of the site clearance.
