6 Abermorlais Terrace, Merthyr Tydfil CF47 8HU is a well-located mid-terrace property just a short walk from the town centre. The property offers spacious accommodation across two floors, with potential to be configured as a six-bedroom HMO with shared kitchen and bathroom facilities.

Situated in a quiet residential area with on-street parking and close to public transport links, the property also benefits from nearby public car parks. There is sufficient space at the front of the property to accommodate the required bin provision, and the rear yard offers additional space for secure bicycle storage. Local amenities are within easy reach, making this an ideal opportunity for high-quality shared accommodation.
