I've copied the previous discussions regarding this site. We're ready to send the refusal to the applicant and have addressed the matter of access and landownership: "*It is noted that the pavement that runs along the side of The Norton is an adopted pavement and the carriageway located beside the pavement is within the Council's ownership but does not form part of the adopted highway. It has been confirmed by the Head of Property and Estates that the applicant does not have any right of access over the land nor has any agreement to secure a right of access been granted. As such, the Estates Department has no option other than to object to the proposal.*" Are you happy with this approach?
